Gift Through Your Will

- In consultation with your advisor, you could include a statement in your Will that may be as simple as the following:
- "I ___full name___ bequeath to The Parish Church of St. Luke (BN 108099771RR0035), 1382 Ontario St, Burlington, L7S 1G1,____% percent of the residue (or a specific dollar amount) of my estate for its own sole & only use absolutely."

Gifts of Securities

Gifts of securities are a cost-effective opportunity to transform a past investment into immediate and significant support for St. Luke's. By donating appreciated stocks, mutual funds, stock options, or flow-through shares directly to St. Luke's, there may be tax benefits to your estate. You have the option of giving now or as part of your estate and Will planning.

Gifts of Life Insurance

Gifts of life insurance are a cost-effective opportunity to transfer modest premium payments into a significant gift. There are a couple ways to donate your life insurance policy. You can either make St. Luke's a beneficiary or you can make St. Luke's owner and beneficiary – depending on when you would like to receive a tax receipt. It's important that you connect with your Life Insurance provider as you make this decision.
